- Gewaarmerkte afskrif van bewys van woon- of besigheidsadres in die **HESSEQUA** area.

Kriteria:

- Moet 'n lewensvatbare onderneming wees wat ten **minste 2 jaar bedryf (uitbreiding), 0-2 jaar (begin)** met bewys van bedrywigheide of handel.
- Moet beskikbaar wees om 'n voorlegging aan 'n geselekteerde paneel te doen en om die verpligte besigheidsontwikkelingsintervensies en - opleiding wat geïdentifiseer is, by te woon;
- Moet belastingnakomend wees. (Indien nie, dien belastingaangeleenthede in met die aansoek om aanslag);
- 100% Suid-Afrikaanse Besigheid/ bedryfwighede besit;
- Aansoeker moet in volle beheer van besigheid en bedrywigheide wees.
- Verkieslik moet die besigheid formeel geregistreer of geïnkorporeer word by die Kommissie vir Maatskappye en Intellektuele Eiendom (CIPC)
- Werkzaam in die **HESSEQUA - omgewing**; en
- Geklassifiseer as 'n mikro- of klein onderneming ingevolge die Wet op Nasionale Klein Ondernemings.

SMME KICK-START PROGRAM – APPLICATION FOR BUSINESS PROPOSALS

Hessequa Local Municipality are implementing a program to support dynamic and dedicated entrepreneurs in growing their businesses. A wide range of non-financial assistance will be provided, including business development interventions (equipment and production materials) as well as access to business training. **Successful candidates from previous Kickstart programs will not be considered.**

IMPORTANT: Applicants must complete and submit a complete application form with documentation attached as instructed below. Physical copies of this application form are available at the Hessequa Municipality's Economic Development Office, located at the corner of President CR Swarts Street, Riversdal, with the contact person being Mr. Wade Adonis at wade@hessequa.gov.za.

The following supporting documents must accompany the application form:

- Company profile or Business Proposal or Business Plan.
- Proof of Profit/Loss Summary or recent Business Financial/Bank Statements, which will be handled confidentially.
- Tax clearance certificate.
- Company Registration Certificate.
- Certified ID copies of all directors.
- Certified copy of proof of residential or business address in the **HESSEQUA** area.

Criteria:

- Must be a viable business operating for at **least 2 years (expansion) or 0-2 years (start-up)** with proof of operations or trading.
- Must be available to present to a selected panel and attend the mandatory business development interventions and training identified by the panel.
- Must be tax compliant. (If not, tax matters must be submitted with the application for assessment.)
- 100% South African-owned business.
- Applicant must have full control of the business and operations.
- Preferably, the business should be formally registered or incorporated with the Companies and Intellectual Property Commission (CIPC).
- Must operate in the **HESSEQUA area**.
- Classified as a micro or small enterprise according to the National Small Business Act.

All applications must be clearly marked as **HESSEQUA MUNICIPALITY SMME KICKSTART PROGRAM 2026**.

Applicants who are not contacted by the Municipality within 30 days after the closing date must consider their application unsuccessful. **Shortlisted applicants will be expected to present their business concepts to an evaluation panel.**
